The undersigned expressly acknowledges that his/her participation will involve such hazards.

Release of Sponsors: RELEASE, DISCHARGE, AND COVENANT NOT TO SUE the rodeo committee, stock contractor, rodeo association, sponsors, arena operators or owners, and each of them, their officers, agents and employees (all hereafter collectively referred to as "Releasee") from any and all claims and liability arising out of strict liability or ordinary negligence of Releasee, or any other participant which causes the undersigned injury, death, damages, or property damage. We, the undersigned, jointly and in common, covenant to hold Releasee harmless and to indemnify releasee from any claim, judgment or expenses releasee may incur arising out of any of this minor's activities or presence in the restricted area.

Assurances: The undersigned has full power, authority, capacity, and right without limitation to execute, deliver, and perform this release.

Rules: The undersigned agrees to abide by all rules governing KJRA

Binding Effect: This release shall be binding upon the undersigned and the undersigned's spouse, legal representatives, heirs, successors, and assigns.

Consent to Treat: I hereby give the local EMS or local hospital the right to treat the above listed child/children, which I am the parent or guardian of, should the need arise.
